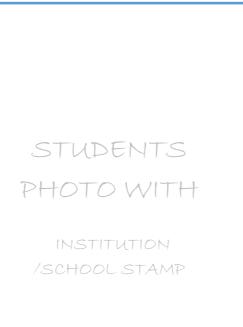

**WHEREAS:**

- ✓ Applicants must download their admit card from Hyperera.in within 20 days of submitting the form and verify all details for accuracy.
- ✓ If an applicant qualifies and participates in the scholarship exam, the fee (Rs. 100) will be refunded for the next scholarship cycle.

2. School/Institution
